

OMIG AUDIT PROTOCOL

OMH DAY TREATMENT PROGRAMS SERVING CHILDREN

Audit protocols assist the Medicaid provider community in developing programs to evaluate compliance with Medicaid requirements under federal and state statutory and regulatory law. Audit protocols are intended solely as guidance in this effort. This guidance does not constitute rulemaking by the New York State Office of the Medicaid Inspector General (OMIG) and may not be relied on to create a substantive or procedural right or benefit enforceable, at law or in equity, by any person. Furthermore, nothing in the audit protocols alters any statutory or regulatory requirement and the absence of any statutory or regulatory requirement from a protocol does not preclude the OMIG from enforcing the requirement. In the event of a conflict between statements in the protocols and either statutory or regulatory requirements, the requirements of the statutes and regulations govern.

A Medicaid provider's legal obligations are determined by the applicable federal and state statutory and regulatory law. Audit protocols do not encompass all the current requirements for payment of Medicaid claims for a particular category of service or provider type and, therefore, are not a substitute for a review of the statutory and regulatory law. The OMIG cannot provide individual advice or counseling, whether medical, legal, or otherwise. If you are seeking specific advice or counseling, you should contact an attorney, a licensed practitioner or professional, a social services agency representative, or an organization in your local community.

Audit protocols are applied to a specific provider type or category of service in the course of an audit and involve the OMIG's application of articulated Medicaid agency policy and the exercise of agency discretion. Audit protocols are used as a guide in the course of an audit to evaluate a provider's compliance with Medicaid requirements and to determine the propriety of Medicaid expended funds. In this effort, the OMIG will review and consider any relevant contemporaneous documentation maintained and available in the provider's records to substantiate a claim.

OMIG, consistent with state and federal law, can pursue civil and administrative enforcement actions against any individual or entity that engages in fraud, abuse, or illegal or improper acts or unacceptable practices perpetrated within the medical assistance program. Furthermore, audit protocols do not limit or diminish the OMIG's authority to recover improperly expended Medicaid funds and the OMIG may amend audit protocols as necessary to address identified issues of non-compliance. Additional reasons for amending protocols include, but are not limited to, responding to a hearing decision, litigation decision, or statutory or regulatory change.

1.	Missing Recipient Record
OMIG Audit Criteria	If the recipient record is not available for review, claims for all dates of service associated with the recipient record will be disallowed.

2.	No Documentation of Day Treatment Service
OMIG Audit Criteria	If recipient records lack documentation that a face-to-face day treatment service was provided, the claim will be disallowed.

3.	Excessive Preadmission Visits
OMIG Audit Criteria	Claims in excess of the maximum allowed three preadmission visits will be disallowed.

4.	Missing Physician Signature on Treatment Plan or Treatment Plan Review
OMIG Audit Criteria	Physician review and approval of the treatment plan or review is substantiated by physician signature. Claims will be disallowed in the absence of a physician signature on the treatment plan or review for the billed service dates within that time frame.

5.	Missing Record of Attendance
OMIG Audit Criteria	There must be a record of all face-to-face contacts with the recipient, the type of service provided and the duration of the contact. The claim will be disallowed if documentation of attendance is missing.

6.	Incorrect Rate Code Billed
OMIG Audit Criteria	For claims for day treatment services that were billed using an incorrect rate code which resulted in a higher reimbursement than indicated for the proper rate code, the amount of the claim disallowed will be the difference between the incorrect rate code amount billed and the correct rate code amount.

7.	Incorrect Collateral Billings
OMIG Audit Criteria	Collateral persons are defined as (1) members of the recipient's family or household; (2) significant others ... identified in the treatment plan; or, (3) significant others ... identified in preadmission notes. Claims for services billed for individuals not meeting the definition of collateral persons, or if the collateral person is not listed on the recipient's treatment plan or in preadmission notes, will be disallowed.

8.	No Explanation of Benefit (EOB) for Third Party Health (TPHI) Covered Service (Excluding Medicare)
OMIG Audit Criteria	If an EOB for a TPHI (commercial carrier) covered service is not found, the claim will be disallowed.

9.	Improper Medicaid Billings for TPHI Recipients (Excluding Medicare)
OMIG Audit Criteria	If Medicaid's co-payment is incorrect, the amount of the claim disallowed will be the difference between Medicaid's incorrect co-payment billed and the correct co-payment amount.

10.	Billing for Unauthorized Services
OMIG Audit Criteria	Claims for services that are not authorized by the provider's operating certificate will be disallowed.

11.	Failure to Bill Medicaid Managed Care
OMIG Audit Criteria	Claims will be disallowed for services billed to Medicaid that bypass the Medicaid Managed Care company responsible for payment.

12.	Missing Progress Note
OMIG Audit Criteria	For day treatment services, progress notes related to treatment plan goals must be recorded at least every week. If the progress note is missing, claims will be disallowed for all visits within that specific interval for services that were to have been summarized by the progress note.

13.	Missing Individual Treatment Plan
OMIG Audit Criteria	A written individual treatment plan must be completed within 30 days of admission. Claims for services provided on the 30 th day after the admission date will be disallowed if the written individual treatment plan is missing.

14.	Late Individual Treatment Plan
OMIG Audit Criteria	<p>A written individual treatment plan must be completed within 30 days of admission. Claims for services provided on the 30th day after the admission date will be disallowed if the written individual treatment plan is not completed timely.</p> <p>Claims for services will be disallowed until a written individual treatment plan is completed. The treatment plan is considered completed upon the signature of the primary counselor or supervisor.</p>

15.	Missing Documentation of Treatment Plan Review
OMIG Audit Criteria	<p>A treatment plan review must take place at least every three months. Claims will be disallowed for billed service dates during any time for which there is no documentation of a treatment plan review in the recipient's record.</p>

16.	Duration of Day Treatment Visit Not Documented
OMIG Audit Criteria	<p>There must be a record of all face-to-face contacts with the recipient, the type of service provided and the duration of the contact. If the duration of the day treatment visit is not documented in recipient records, the claim will be disallowed.</p>

17.	Failure to Meet Minimum Duration Requirements
OMIG Audit Criteria	<p>Claims for visits of less than one hour in duration for regular or preadmission day treatment services, or less than 30 minutes for collateral, crisis or home visits will be disallowed.</p>

18.	Billing for Nonreimbursable Services
OMIG Audit Criteria	<p>Educational only services documented without the required additional billable day treatment service will be disallowed.</p>
