This is the Office of the Medicaid Inspector General's (OMIG) Final Audit Report for Affinity Health Plan, Inc. (Plan).

In accordance with the Medicaid Managed Care/Family Health Plus/HIV Special Needs Plan Model Contract and Title 18 of the Official Compilation of the Codes, Rules and Regulations of the State of New York Section 517.6, this Final Audit Report represents the final determination on the issues found during OMIG's audit.

After reviewing the Plan's July 26, 2019 response to OMIG's May 17, 2019 Draft Audit Report, the overpayments in this Final Audit Report remain unchanged from those overpayments identified in the Draft Audit Report. Based on this determination, the total amount due is \$1,590,509.79, inclusive of rate adjustments. A detailed explanation can be found in the Audit Findings section.

# Background, Objective, and Audit Scope

#### Background

The New York State Department of Health (DOH) is the single state agency responsible for the administration of the Medicaid program. As part of its responsibility as an independent entity within DOH, the Office of the Medicaid Inspector General (OMIG) conducts audits and reviews of various providers of Medicaid reimbursable services, equipment, and supplies. These audits and reviews are directed at assessing provider compliance with applicable laws, regulations, rules, and policies of the Medicaid program as set forth in New York Public Health Law, New York Social Services Law, the regulations of DOH (Titles 10 and 18 of the New York Codes, Rules and Regulations), the regulations of the Department of Mental Hygiene (Title 14 of the New York Codes, Rules and Regulations), DOH's Medicaid Provider Manuals, Medicaid Update publications, and the Medicaid Managed Care/Family Health Plus/HIV Special Needs Plan Model Contract (Contract).

In accordance with 18 NYCRR Parts 517 and 518, and pursuant to the Contract, Section 3.6 (SDOH Right to Recover Premiums), Section 19.7 (OMIG Audit Authority), and Appendix H, the OMIG, on behalf of DOH, has a right to recover premiums paid to the Plan for enrollees listed on the monthly roster who are later determined to have been ineligible for the entire applicable payment month.

#### Objective

The objective of this audit was to assess the Plan's adherence to applicable laws, regulations, rules and policies governing the New York State Medicaid program and to verify that:

 monthly capitation payments are recovered when both a capitation payment and a foster care daily rate payment were made by Medicaid for the same child, for the same payment month.

#### **Audit Scope**

This audit identified instances where both a monthly capitation payment and a foster care daily rate payment were made by Medicaid for the same child, for the same payment month. This audit included capitation payments made to the Plan for dates of service beginning January 1, 2017 and ending December 31, 2018.

#### **Audit Findings**

OMIG issued a Draft Audit Report to the Plan on May 17, 2019 that identified \$1,590,532.22 in Medicaid overpayments due to capitation payments made for enrollees who were retroactively disenrolled and placed in foster care which provided a medical per diem for the child's medical coverage. The Plan's July 26, 2019 response (Attachment A) to the Draft Audit Report disputed 521 of the claims identified. After reviewing the Plan's response to the Draft Audit Report, the overpayments identified (Attachment B) in this Final Audit Report remain unchanged from those cited in the Draft Audit Report. During the audit process a rate adjustment of \$22.43 occurred decreasing the overpayment to \$1,590,509.79. Pursuant to Section 3.6, Section 19.6, and Appendix H of the Contract, and Title 18 of the Official Compilation of the Codes, Rules and Regulations of the State of New York (18 NYCRR) Parts 517 and 518, OMIG, on behalf of DOH, may recover such overpayments.

Based on this determination, the total amount due to DOH, as defined in 18 NYCRR Section 518.1, is \$1,590,509.79 (Attachment B). Subsequent to the issuance of the Draft Audit Report, the Plan submitted claim voids in the amount of \$1,469,619.99. Therefore, \$120,889.80 is due to DOH.

# **Repayment Options**

In accordance with 18 NYCRR Part 518, which regulates the collection of overpayments, your repayment options are described below.

Option #1: Make a full payment by check or money order within 20 days of the date of this Final Audit Report. The check should be made payable to the New York State Department of Health with the audit number included, and be sent with the attached remittance advice to:

Option #2: Enter into a repayment agreement with OMIG. If your repayment terms exceed 90 days from the date of this Final Audit Report, recoveries of amounts due are subject to interest charges at the Prime Rate plus two percent (2%). If the process of establishing the repayment agreement exceeds 20 days from the date of the final audit report, OMIG will impose a 50% withhold after 20 days until an agreement is established. OMIG acceptance of the repayment agreement is based on your repaying the Medicaid overpayment as agreed. OMIG will adjust the rate of recovery, or require payment in full, if your unpaid balance is not being repaid as agreed. In addition, if you receive an adjustment in your favor while you owe funds to New York State, such adjustment will be applied against any amount owed. # **Hearing Rights**

The Plan has the right to challenge this action and determination by requesting an administrative hearing within sixty (60) days of the date of this notice. In accordance with 18 NYCRR 519.18(a), "The issues and documentation considered at the hearing are limited to issues directly relating to the final determination. An appellant may not raise issues regarding the methodology used to determine any rate of payment or fee, nor raise any new matter not considered by the department upon submission of objections to a draft audit or notice of proposed agency action."

If the Plan wishes to request a hearing, the request must be submitted in writing within sixty (60) days of the date of this notice to:
